### Spring 2012 Treasurer's Report - Cheryl Findlay

As of 5 February 2012, the FSFF account has a balance of \$4281.81. Recent expenses include the payment of 2012 dues to the Federation of Fly Fishers of \$232.00, supplies for the fly-tying class of \$86.80, and supplies for clubhouse maintenance of \$94.52. So far this year the Club has received \$315.00 in dues, \$15 from raffles and \$40 from sales of hats. Form 900-N for the IRS Federal Taxes has been filed for the year (no payment is needed). State tax forms will be filed in March.

Free State Fly Fishers hats are now available for sale at the monthly meetings for \$20.00. They are very nice quality Adams brand with a cool-mesh liner and leather-buckle strap. FSFF coffee mugs and cooler bags are also available at the monthly meetings for \$3.00 each.



March begins with a trip to the York area of Pennsylvania in pursuit of trout on Muddy Creek and other local streams with club member John Scarborough. April brings an outing closer to home with an outing to the Gunpowder River for trout in Baltimore County with club member George Vincent, listen for more trip information at our March meeting and a follow-up email to members in late March.

When the shad start running in mid-April, an evening a trip to Deer Creek is planned with Tom Gooding leading a club favorite outing. In May, club member Larry Meyer will lead a trip to the Patapsco River in search of smallmouth bass. ### **Basic Fly Fishing Class**



The Free State Fly Fishers will hold a basic fly fishing class on Sunday, April 29<sup>th</sup> from 1PM to 4PM in Ford Hall at the Davidsonville Family Recreation Center. A nominal charge of \$15 or \$10 for members over 65 includes a year's membership.

The *Basic Fly Fishing class* consists of three parts:

1. A session on flies and bugs (entomology);

2. A session on fly fishing equipment rods, reels, lines and gadgets;

This class is intended to those who are new to the sport or those who would like to get started in fly fishing. Participants should bring their own rod and reel if they have them. ### Maryland has several locations which are managed as Delayed Harvest Trout Fishing Areas

As the title implies, these locations are restricted to catch and release fishing only up until a specific date. Delaying harvest offers several benefits to anglers, including a larger number of fish to be caught, and these longer term acclimated fish exhibit a more natural trout feeding behavior, allowing fly fishermen to have additional opportunities to test their skills matching hatches on the streams with delayed harvest regulations. In contrast, most put and take streams are "fished down" after several days and the fish that are stocked are often geared toward feeding on pellet food from the hatcheries. Multiple stockings of delayed harvest areas offer trout fishermen a higher success rate over a longer period of time, with the bonus of providing a late spring or early summer five fish creel limit long after most of the put and trout streams have seen peak catches of trout. There are two distinct groups of designated Delayed Harvest Trout Fishing Areas. Check your Maryland Fishing Guide for details.

### Whirling and Other Diseases

**MDNR** is asking anglers to continue to be vigilant about not spreading whirling, other disease and invasive organisms. Please remember to clean your gear between streams or outings to prevent moving around unwanted invaders like didymo and whirling disease. Scrub all gear to remove mud and plants.

### Monofilament Recycling Program

When monofilament line is not properly discarded it becomes a major hazard to fish, wildlife and human recreation in our rivers, estuaries oceans and surrounding land. Marine ecosystems are particularly at risk to the dangers of waste monofilament. All kinds of wildlife are impacted by waste monofilament. Everything to birds, sea turtles, alligators,



manatees and of course fish! Fish and other wildlife can become wrapped in monofilament making th em unable to avoid predators, hunt for food

and ultimately result in their death.

We need your help! Please dispose of monofilament properly. If your line becomes tangled in trees or underwater - don't leave a mess for a bird or fish to tangle in. Remove and dispose of as much of the waste line as possible. In some communities there are active monofilament recycling programs. Your club, business or community group can bring a recycling receptacle to your favorite fishing access. The recycled monofilament is made into other useful plastic products like fishing gear boxes.

### **FFF Announcements**

The Federation of Fly Fishers supports the rights of anglers to recreationally pursue fishing in the waters of the United States.

The U.S. Clean Water Act of 1972 establishes a policy of maintaining fishable waters. The Federation of Fly Fishers and its members wholeheartedly accept this provision and adopt the following pro-active policy in support of the Clean Water Act.

#### The Federation of Fly Fishers and its members shall...

- Support the Federal and State environmental agencies in their implementation and enforcement of water quality standards applicable to fish.
- Coordinate our volunteer activities and financial resources with other conservation and environmental organizations seeking to protect water quality;
- Participate in clean-up and restoration projects to build or improve fisheries;
- Encourage our members to monitor our favorite fishing streams and lakes by utilizing the appropriate tests from the FFF or other sources to measure temperatures, dissolved oxygen, turbidity, and other state and federal water quality measures to assure compliance with established standards;
- Report pollution events (oil and chemical spills, suspected polluting outfalls, violations of water quality standards, etc.) to emergency and enforcement officials.
- In appreciation of the quality resources gifted us by our forbearers; we shall leave these resources no less diminished to our children.
