



## Free State Fly Fishers Outing

**When:** Thursday, August 29<sup>th</sup> 2024

**Where:** Blairs Pond (morning) and Griffin Lake (afternoon)

**Meeting Time/Location:** 6:00 AM at the Shopping Center on Route 50 on the right hand side just past Anglers and just before the Chesapeake Bay Bridge. We will leave the parking lot at 6:15 AM sharp. Please let Mike know if you plan to participate in this outing.

**Directions to the Fishing Location:** Take Route 301 N/ Route 50 East over the Chesapeake Bay Bridge. Continue on US-301 N/US-50 E. Drive from MD-404 E to Denton. Take the MD-619 N exit from MD-404 E. Take MD-317 E, DE-14 E and Hammondtown Rd to Williamsville Road. Enter the address "Blairs Pond Boat Ramp Milford, DE 19963" into your mapping app.

**Species of Interest:** Largemouth bass, crappie, bluegill, yellow perch, white perch and pickerel.

**Equipment Needed:** Recommend 5-6 weight of rods with floating and intermediate lines. The fish are not leader shy so recommend a 7-9' leader for casting with your floating line and a 6' leader with your intermediate line both with 2x or 3x tippets. Strongly recommend bringing your kayak, canoe, SUP, or boat as both Wye Mills Lake and Tuckahoe Lake have limited shoreline fishing for those without a kayak, canoe or a boat.

**Recommended Flies:** Bring a good selection of your favorite panfish flies including wooly buggers, crystal buggers, Golden Retrievers, bluegill bullies, poppers, gurglers and spiders along smaller sized largemouth bass flies including Clousers, bendbacks, and bulletheads.

**License Required:** Delaware fishing licenses are available on-line at <https://dnrec.delaware.gov/fish-wildlife/licenses/> or in person at Walmart stores located in Delaware. Please note that Delaware fishing licenses are free to senior citizens!

**Other Trip Logistics and Fishing Information:** We will fish Blairs Pond in the morning. We will break for then lunch at a restaurant to be determined and then fish in the afternoon at Griffin Lake.

**Safety:** Safety is a paramount concern on all FSFF sponsored outings. On all FSFF sponsored outings, please be safe out there as it is your responsibility to stay within your capabilities and practice water safety at all time. Check with the above listed outing coordinator for more information on the fishing conditions if you have any concerns or questions. If boating, always wear your PFD and if water temperatures are below 60 degrees F, have a plan to protect yourself from cold water immersion hazards should you fall in.

**Liability Waiver:** It is mandatory that any trip attendees of this trip sign the FSFF Liability Waiver and submit them to Frank Bowne, FSFF Membership Coordinator.
